1. Customer orders, Supplier undertakes to sell exclusively owned 1x Hongyuan ZL28 telescopic loader to the Customer.

2. Contents of the contract:

- Hongyuan ZL28 telescopic loader with bucket: 24375 EURO
- air conditioning: 750 EURO
- 1 pair hooks: 75 EURO
- transport loader to Slovakia: 875 EURO
- grapple: 1250 EURO
- Transport grapple to Slovakia: 440 EURO

The condition of the products is new, delivered from the manufacturer to the Supplier's commercial site in perfect condition.

3. Total contract price:

- Netto price: **27.765 EURO**

4. This Agreement is a transferable property contract for consideration.

5. The supplier shall hand over the machine and accessories referred to in paragraph 1 to the buyer and shall relinquish ownership thereof in exchange for payment of the purchase price.

The customer declares that he will take possession of the machine and accessories referred to in paragraph 1.

6. The contract price shall include the costs of on-site training necessary for the operation of the machine and a detailed description of daily and regular maintenance activities.

7. Delivery time: The machine is in stock and the delivery time is 10 days from the date of payment.

8. The delivery time may be adjusted as necessary only by mutual agreement of the parties.

11. Warranty:

The Supplier undertakes a full warranty for 12 months from the date of commissioning by the Customer. Unauthorized service will void the warranty.

12. At the same time as handing over the machine and its accessories referred to in paragraph 1, the Supplier shall hand over all necessary documents, documentation, keys and instructions for handling and maintenance in the Hungarian language to Customer, acknowledging receipt thereof by signing this contract.

The Supplier warrants that Buyer will acquire unrestricted ownership. There is no third party right in the assets covered by the contract that prevents the acquisition of ownership, and no restriction on distribution is recorded in the register.

13. The Customer declares that he will receive the said machine and its accessories in a reviewed and tested condition.

14. The Supplier declares and warrants that it is a company incorporated in Hungary.

15. In matters not regulated by this Agreement, the Civil Code. the provisions of its regulations shall prevail.

16. This contract has been read and signed by the Customer and the Supplier in the same manner as was their will.
